#### 1. <u>Institute Days</u>

#### 3. City of Modesto Water Fees – MJC West Campus

In October 2002, the Modesto Junior College West Campus connected to City of Modesto water permanently due to the contamination of the primary well. After following directions by the Department of Environmental Resources to decontaminate the well, which were unsuccessful, we were directed to take the well off-line. Efforts have been made to utilize the remaining active well for the agricultural lab facilities and Modesto Irrigation District for irrigation of pastures. As staff were exploring options to diminish the usage of City water, they learned of a flat rate fee charged to schools and churches per City Council Resolution. Staff discovered that the MJC East Campus was being charged the flat rate fee in addition to several metered properties, but that the MJC West Campus was entirely metered. The City of Modesto water fees for MJC West since October are in excess of \$100,000. Discussions have since occurred with City staff to rectify what was felt to be an overcharge of fees for MJC West Campus. City staff indicated that since the flat rate fee charged to schools was by City Council Resolution, the issue needed to be reviewed by the Finance Committee and perhaps go to the Council for a final decision on whether or not MJC West Campus should be included in the flat rate formula. District staff believe there should not be a distinction made between MJC East and West campuses regarding the water rates charged by the City of Modesto. District staff will be available to answer questions and provide additional information.

#### D. Presentations/Updates (continued)

#### 4. YCCD State Funded Child Care Programs

All state funded child care programs are required to complete an annual self-evaluation to insure compliance with mandated program elements. YCCD currently administers three state child care contracts: one at Columbia College and two at Modesto Junior College. Staff have completed the self-studies and the presidents have reviewed them. The programs are in compliance, but did identify a couple of areas needing some attention. This presentation fulfills one of the compliance requirements of informing the Board of Trustees of the results of the self-studies.

The staff at Columbia College's Child Care Center identified a need to improve communication between Center staff and parents. Plans include recruiting a parent committee that will meet regularly, hosting an annual fall family event, increasing daily interactions and publishing regular newsletters.

Modesto Junior College's Infant and Toddler Center and State Preschool staff also found gaps in communication and participation. Staff are in the process of involving parents in the classroom with a volunteer calendar. The Director also plans to improve the documentation of referral services provided to parents.

#### C. Discussion Items

#### 1. <u>State Budget Status and Local Cash Flow Options</u>

As this agenda item goes to print, both the California State Senate and Assembly have approved a state budget plan and have forwarded it to the Governor for his signature. The plan reduces the \$38.2 billion shortfall through a combination of borrowing, tax shifts, fees and spending cuts, but still leaves California with an \$8 billion gap in fiscal year 2003-04.

Initial analysis indicates that community colleges will receive approximately the same funding as last year. However, \$38 million of that funding is targeted for student financial aid only, therefore our operating funds will in fact be less than in fiscal year 2002-03 after the mid-year cuts. Since the Governor has line-item veto authority, final details may not be known for days or weeks. However student fees are expected to increase from \$11 to \$18 per unit.

Absent a state budget, the State Controller had announced that cash payments to community college districts would cease. This public warning made clear the impact of a budget impasse on Californians across the state.

Although the Governor is now expected to sign the budget bill (AB1765), staff had previously explored short-term cash borrowing options available to the District. The District's cash flow projections, in the event that the budget was not signed, showed the District depleting the General Fund unreserved cash by August 31, 2003 when the end of the month payroll and benefit payments were made. Since the average monthly salary and benefit costs are about \$5.5 million, an estimated \$600,000 of the District's \$4.4 million reserve would need to be transferred to the unrestricted General Fund to cover the August payroll. The District would need to use the remaining reserve in September and would end the month of September in a cash deficit position of approximately \$2 million.

Depending upon how quickly the budget is signed, it may be necessary to temporarily use YCCD Board reserve funds and/or Retiree Liability funds. Staff will present the latest budget information at this meeting.

#### RECOMMENDATION:

That the Board of Trustees approve the transfer of General Fund and Retiree Liability Fund reserves to the Unrestricted General Fund for the purpose of meeting the District's financial obligations until a state budget is passed. Such transfers will be returned when funds are received from the State.
